Information Request: IR0155

Dear Ms. d'Auray:

As you are likely aware, the Parliamentary Budget Officer (PBO) provides independent analysis to the Senate and to the House of Commons about the nation's finances and the economy, the estimates of the government, and the cost of programs, legislation, and policies. In carrying out its mandate, the PBO often requires access to information held by government departments. When such information is needed, the PBO makes a request to the department holding the information.

The PBO is currently undertaking an analysis pursuant to section 79.2(d) of the Parliament of Canada Act, which mandates the PBO to estimate the financial cost of any proposal that relates to a matter over which Parliament has jurisdiction at the request of a member or committee of either a House or a joint committee of both Houses.

In pursuing this work, the PBO would ask that, in accordance with the *Communications Policy of the Government of Canada*, you provide access to the following information:

- Information pertaining to Irving's Halifax Shipyard and the A/OPS project, including:
 - (1) the number of prime contractors employed by Irving;
 - (2) the total number of contractors employed by Irving;
 - (3) the number of suppliers supplying Irving;

(4) the number of employees who will be managing the project, broken down by

- (a) trade/skill,
- (b) employee group/job title, and
- (c) years of service/experience (an example spreadsheet is attached);

(5) the number of employees who will be involved in design/development work, broken down by

- (a) trade/skill,
- (b) employee group, and
- (c) years of service/experience (see example spreadsheet);

(6) the number of employees who will be manufacturing the A/OPS (e.g. direct labour), broken down by

- (a) trade/skill,
- (b) the employee group/job title, and
- (c) years of service/experience (see example spreadsheet); and

(7) a list of all ships, including their tonnage and classification, built at Halifax Shipyards in the past decade.

We would appreciate that you provide access to this information by 20 May 2014.

Attached is a reply form. It too should be filled out and returned by 20 May 2014, whether or not you provide access to the requested information. The details contained in the reply form will assist us in preparing the PBO annual report.

Your response letter will be posted on the PBO website and, therefore, it should not be marked "confidential". Please attach the requested information separately as appendices. For any information you provide that is confidential, please clearly mark it "confidential."

I want to thank you for your assistance in this matter. Providing timely and effective analysis to the Senate and House of Commons is the PBO's primary objective.

The degree to which this is possible depends, to a large extent, on free and timely access to quality information held by government departments. In doing so, you are assisting us in better serving the Senate, the House of Commons, and their members.
