Pursuant to statutory authority under section 79.3(1) of the *Parliament of Canada Act*, I would like to request information and data surrounding the anticipated changes referenced in the fiscal update surrounding changes to employer pension contributions and severance benefits.

Specifically, I request a five-year savings profile that reflects the expected savings from the following items referenced in the fiscal update:

- (1) Changes to federal employee pension plans included in the *Jobs and Growth Act, 2012*; and,
- (2) Changes to the Members of Parliament pension plan included in the *Members of Parliament Retiring Allowances Act*.

Any data or information you share would be used by my staff to perform analysis of the state of the nation's finances and government's estimates.
