Dear Mr. Yeates:

Pursuant to my mandate to provide independent analysis to the Senate and the House of Commons under s. 79.2(a) of the *Parliament of Canada Act*, 1985, I would like to request data pertaining to funding authority adjustments contained in the Supplementary Estimates, delineated by Program Activity.

- Specifically, if your Ministry is presented in the Supplementary Estimates documents, I am requesting a list of all adjustments to budgeted total Program Activity expenditures that have occurred since these data were presented to Parliament in the Main Estimates.

On the face of it, these data do not themselves constitute cabinet confidences as described in s. 69(1) of the *Access to Information Act*, 1985. If they are contained in a memorandum to Cabinet, they must be severed and disclosed pursuant to s. 25. As described in *Canada (Information Commissioner) v. Canada (Minister of the Environment)* (2001), any data contained in a memorandum whose purpose is to provide background explanations, analyses of problems, or policy options, must be severed and considered to fall within the exception to s. 61(1) found in s.69(3).

Any data or information you share would be used by my staff to perform research and analysis of the Government of Canada's Estimates.
