Information Request: IR0351

Dear Minister Sajjan:

As you are likely aware, the Parliamentary Budget Officer (PBO) provides independent and non-partisan analysis to the Senate and to the House of Commons about matters related to the nation's finances and the economy, the estimates, certain other documents government documents and the cost of proposals. In carrying out my mandate, I often require information held by government departments and Crown corporations and I am entitled to free and timely access – subject to limited exceptions – to such information under section 79.4 of the *Parliament of Canada Act*.

I am currently undertaking an analysis pursuant to subparagraph 79.2(1)(c)(ii) of the *Parliament of Canada Act*, which mandates the PBO to undertake research on the nation's finances and economy at the request of the Standing Committee on Finance of the House of Commons.

For this analysis, I am asking/requesting the following information:

- I. A complete list of the projects budgeted in "Strong, Secure and Engaged: Canada's Defence Policy fiscal framework", annexes A and B.
- II. The above data must be presented on a project-by-project basis, categorized by branch (e.g. RCAF, Army, Navy, etc).

For each project please provide:

- the project financial data presented annually over the 20-year plan, both in cash and accrual accounting frameworks

- lifecycle information, project start and completion dates, and other information and assumptions relevant to constructing the 20-year financial accounting profile.
- Include separately the financial details of any interim adjustments made to projects' budget projections, up to January 26, 2018.

Based on the nature of this request and the analysis I am undertaking, I believe a reasonable deadline would be 28 February 2018. A response must be provided if access to the requested information cannot be granted by that date.



If this information is confidential, please clearly mark it as such, either on the electronic spreadsheet or the hard copy version.

I want to thank you for your assistance in this matter. Providing timely and effective analysis to the Senate and House of Commons for the purposes of raising the quality of parliamentary debate and promoting greater budget transparency and accountability is the PBO's primary objective. The degree to which this is possible depends, to a large extent, on free and timely access to quality information held by government departments. In doing so, you are assisting us in better serving the Senate, the House of Commons, and their members.
