- EX and equivalent (EX, EC within Canada Revenue Agency and MG within National Research Council)
- AS: Administrative Services
- FI: Financial Administration
- Engineering (EN-ENG, EN-SUR)
- General Labour (limited to GL-EIM, GL-ELE, GL-MAM, GL-MDO): Electrical Installing and Maintaining, Elemental, Machinery Maintaining, Machine Driving and Operating

Please provide this information on an annual basis per Annex 1 to this information request.

In addition, I seek information relating to Section 6, a Knowledge-Intensive Workforce, surrounding the highest educational attainment for the same classifications listed herein on an annual basis starting in 2000-01 and for each year until the most recent year for which data are available according to the following categories (aligned with the Canadian Labour Force Survey):

0. 0-8 years
1. Some secondary
2. Grades 11 to 13, graduate



3. Some post-secondary
4. Post-secondary certificate or diploma
5. University: bachelor's degree
6. University: graduate degree
