Dear Ms. d'Auray:

I would like to request additional data records from the Central Financial Management Reporting System (CFMRS). Specifically, I would like the expenditures for Government-Wide Activity Code ISC*, also known as “Internal Services”, delineated by *Standard Object*, *Reporting Object* and *Economic, Source and Class Objects* (<http://www.tpsgc-pwgsc.gc.ca/recgen/pceaf-qwcoa/1213/7-eng.html>). I am seeking this historical data for 2009-10; 2010-11 and 2011-12; as well as subsequent fiscal years, following tabling of future Public Accounts of Canada.

Consistent with the current terms under which your department shares data records from the CFMRS (http://www.pbo-dpb.gc.ca/files/files/IR/PBO_Info_Request_008.pdf), I understand that you will continue to exclude the detailed financial data for the legislative branch entities (*i.e.* House of Commons, Senate, Library of Parliament, Office of Conflict of Interest and Ethics Commissioner and Senate Ethics Officer).

My office will use this information for its research to track past trends in the federal expenditures, beyond the publicly reported aggregate data.
